KEY ACCOUNT APPLICATION FORM

This is an agreement between us, Magnet Expert Ltd and you to provide up to 30 day business credit account (the "Account") which you can use to make purchases from Magnet Expert Ltd and its subsidiaries. You will be deemed to have consented to have these terms by your use of the business credit account.

1. You must supply an official Purchase Order for every order you wish to place which details a purchase order reference, product descriptions and price information. We retain the right to reject Purchase Orders that do not contain all relevant information.

2. We will set a credit limit for your Account and tell you what it is. Your account will be temporarily suspended when you reach your credit limit until you have made payment to clear the account balance.

3. You will be sent an invoice for each Purchase Order we receive and fulfill unless otherwise agreed. Payment must be made within 30 days of the invoice date. Any payment to us must be in Pounds Sterling by way of BACs, Faster Payments or CHAPS or as otherwise notified by us to you.

4. By signing these terms, shipping will be charged dependent on weight and size of the shipment which will be confirmed prior to dispatch

5. If you do not repay the outstanding balance on the Account in full and on time, you may be charged interest at the rate of 1 ½ % per month (18% per annum) on any such overdue amounts from the due date until payment is made in full. Interest will be calculated on a monthly basis. We will notify you of any interest that is charged. If you do not repay the outstanding balance on the Account in full and on time, we may also add to the account the costs and reasonable charges we incur including reasonable costs of collection and solicitor fees.

6. We reserve the right to close your Account immediately on us giving you notice

if you exceed the credit limit or if you break any of these terms of the terms on which you purchased goods or if any of the following happens (or we reasonably believe is likely to happen):

(a) If you are a company any step, application, order, proceeding or appointment for a distress, execution, composition or arrangement with creditors, winding up, dissolution, administration, receivership (administrative or otherwise) or bankruptcy is taken or made, or you are unable to pay your debts.

7. You may end this agreement at any time by giving us notice and by paying in full any outstanding balances on the Account.

8. You must tell us immediately if;

(a) You become aware that the Account is being misused, whether fraudulently or in any other way; or

(b) There are any discrepancies on your delivery notes, invoices or statements.

9. We shall not be liable to your company if we are unable to comply with our obligations under this agreement due, directly or indirectly, to any industrial action or data processing or transmission link failure beyond our reasonable control.

10. We may send you any notice at the address you notify to us (by post or electronically) or any other address you notify to us in writing. You must tell us if you change your address. 11. This agreement shall be governed by the laws of England & Wales.
